## Summer 2022 Open House Giveaway Contest to win up to \$2,500 tuition grant

### OFFICIAL CONTEST RULES AND REGULATIONS SECTION 1: CONTEST PERIOD

Starting [Friday, July 1st, 2022] at approximately 9:00 a.m. Eastern Time (EST), the IBU Summer 2022 Open House Giveaway Contest (the “**Contest**”) is open to individual residents of Canada (excluding Quebec) online at **Error! Hyperlink reference not valid.**. The Contest closes at 9:00 AM (EST) on [Wednesday, August, 2022] (the “**Open House Date**”).

### SECTION 2: HOW TO ENTER

NO PURCHASE NECESSARY to enter. Entrants must complete and submit an online Contest entry form (the “Entry Form”) by making an online RSVP to IBU Virtual Open House on or before 9:00 am the Open House Date by providing the entrant’s full name, email and telephone number and attend the Open House to be eligible to win.

### SECTION 3: ELIGIBILITY AND ENTRY TERMS

1. Eligible entrants in the contest are domestic Canadian applicants (excluding Quebec) who apply to IBU’s Bachelor of Commerce (Honours) in International Management and Technology degree (“IBU Program”) on a full-time basis for the academic term beginning September 2022 and who subsequently receive an offer of admission, accept their offer and start attending their courses on [September, 6<sup>th</sup>, 2022 semester inauguration date]. 2. Each entrant is allowed to submit one (1) entry to the Contest. Only one e-mail address and account may be used by any person to enter the Contest. If it is discovered in the ordinary course of running the Contest that an entrant has attempted to submit more than one entry, that entrant may, at the discretion of IBU, be disqualified from the Contest. Should it be discovered that an entrant is using the aid of computer programs to auto-fill entries, that entrant will be immediately disqualified from the Contest.
3. An entrant under the age of 16 is not allowed to participate in the contest. Any Winner under the age of 18 must have a parent/guardian sign an affidavit of eligibility. The Contest is not open to employees of IBU or persons with whom they are domiciled.
4. By entering the Contest, each entrant (and his/her parent/legal guardian if he/she is a minor in his/her jurisdiction of residence) agrees to abide by the Contest rules and all decisions of IBU, which shall be final and binding on all entrants in all matters relating to this Contest. This Contest is subject to all applicable federal, provincial, and municipal laws and regulations. Voids were prohibited by law. IBU reserves the right to cancel or suspend this Contest in the event of any accident, administrative or other error of any kind.

### SECTION 4: PRIZES

1. There is One (1) Grand Prize available to be won, consisting of:
  - a tuition grant valued at up to two thousand and five hundred dollars only

(\$2500) to be applied toward the first-year tuition of the IBU Program in two equal installments for the first and second semester at IBU.

5. All Prizes must be accepted as awarded and are not transferable or convertible to cash. IBU reserves the right to substitute a prize or a prize component with one of equal or greater value. Limit of one (1) Prize per entrant. Prizes will only be awarded to the entrant whose full name and valid email address appears on the Entry Form.
  6. All required documentation for the redemption of the above Prizes will be sent via e-mail directly to the selected entrant. Only after the selected entrant has met the eligibility requirements outlined in these Official Contest Rules and Regulations, and the selected entrant (and his/her parent/legal guardian if he/she is a minor in his/her jurisdiction of residence) has completed, signed and returned the Release Forms (“Release Forms”) to IBU, will the selected entrant be confirmed as, and declared a winner.

A random draw for the Grand Prize and Secondary Prize from all eligible entries received by the Open House Date will take place on August 31<sup>st</sup>, 2022 at approximately 2:00 p.m. EST in Toronto, Ontario. Chances of winning are dependent upon the total number of eligible entries received. Each selected entrant (or his/her parent/legal guardian if he/she is under the age of 18) will be notified by e-mail or telephone at the address/number provided in their application to IBU. If, within seven (7) days of the Draw Date a selected entrant for Secondary Prizes (or his/her parent/legal guardian if he/she is under the age of 18) cannot be contacted, or fails to respond to any attempted contact, such selected entrant will be disqualified, his/her entry will be declared null and void and IBU reserve the right, in its sole and absolute discretion, to select at random another eligible entry, in which event the foregoing provisions of this sentence shall apply to such other eligible entry.

In order to win a Prize, each selected entrant will be required to correctly answer a mathematical skill testing question without assistance or mechanical or electronic aid, and sign (and have his/her parent/legal guardian sign if he/she is a minor in his/her jurisdiction of residence) the Release Forms confirming compliance with the Contest rules and releasing IBU from all liability and acceptance of the Prize as awarded.
